

KILLEEN INDEPENDENT SCHOOL DISTRICT ORDER OF ELECTION

(In accordance with Texas Election Code 3.004, 3.005, 3.006, 4.0008, 83.010, 85.004, 85.007)

THE STATE OF TEXAS: COUNTIES OF BELL AND CORYELL:

WHEREAS, this Board of Trustees deems it advisable to call the election hereinafter ordered for the purpose of electing a representative to the following positions:

School Board Trustee Place 6 (Three Year Term) School Board Trustee Place 7 (Three Year Term)

WHEREAS, it is hereby officially found and determined that holding hereafter called election on a uniform election date established by Section 41.001(a), Texas Election Code, is in the public interest; and that this was determined in a meeting open to the public for which public notice with time, place, and purpose of said meeting was given, all as required by the Texas Government Code 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE KILLEEN INDEPENDENT SCHOOL DISTRICT:

1. That an election shall be held between the hours of 7:00 A.M. and 7:00 P.M. on May 4, 2024 in said District at the regular election precincts of said District, at regular polling places as follows:

Precinct Nos. 101, 111(N), 114(N), and 118, within the boundaries of Nolanville and Bell County within said precincts, at Nolanville City Hall, 101 North 5th Street, Nolanville, Texas.

Precinct Nos. 106, 116, 201(K), and 211(K), within the boundaries of Killeen and Bell County within said precincts, at Rancier Middle School, 3301 Hilliard Avenue, Killeen, Texas.

Precinct Nos. 109, 110, 204, 406, and 410, within the boundaries of Killeen and Bell County within said precincts, at Killeen Utility Collections, 201 West Avenue C., Killeen, Texas.

Precinct Nos. 203, 208, 210, 214(K), and 215(K), within the boundaries of Killeen and Bell County within said precincts, at Cedar Valley Elementary School, 4801 Chantz Drive, Killeen, Texas.

Precinct Nos. 205 and 207, within the boundaries of Killeen and Bell County within said precincts, at Jackson Professional Learning Center, 902 Rev. R.A. Abercrombie Drive, Killeen, Texas.

Precinct Nos. 206, 408, 409, and 419, within the boundaries of Killeen and Bell County within said precincts, at Killeen Lions Club Park Senior Center, 1700-B E. Stan Schlueter Loop, Killeen, Texas.

Precinct Nos. 404, 412, and 415, within the boundaries of Killeen and Bell County within said precincts, at Sugar Loaf Elementary School, Killeen, Texas.

Precinct Nos. 401, 405, and 414, within the boundaries of Killeen and Bell County within said precincts, at Robert M. Shoemaker High School, 3302 Clear Creek Road, Killeen, Texas.

Precinct Nos. 402 and 413, within the boundaries of Killeen and Bell County within said precincts, at Roy J. Smith Middle School, 6000 Brushy Creek Drive, Killeen, Texas.

Precinct Nos. 111(H), 114(H), 201(H), 202, 209, 211(H), 212, 214(H), 215(H), and 216, within the boundaries of Harker Heights, at Harker Heights Recreation Center, 307 Miller's Crossing, Harker Heights, Texas.

Precinct Nos. 206 and 311, in Coryell County at Copperas Cove Voting Center, 508-B Cove Terrace Shopping Center, Copperas Cove, Texas, and HEB (portable building), 2990 US Highway 190, Copperas Cove, Texas.

- 2. That the Presiding Judge shall appoint not less than two or more than four qualified election clerks to serve and assist in conducting said election; provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks.
- 3. That **Early Voting** shall be conducted by personal appearance and by mail at the Main Early Voting Place located at the <u>KISD Jackson Professional Learning Center</u>, 902 Rev. R.A. Abercrombie Drive, Killeen Texas 76543, during the period early voting is required and permitted by law, being April 22 26, and 29-30, 2024, and during the hours designated below for early voting by personal appearance except Saturdays, Sundays, and legal state holidays. The Early Voting Clerk shall keep said Main Early Voting Place open during such hours for early voting by personal appearance. - 4. That **Early Voting** by personal appearance shall also be conducted at Permanent Branch Early Voting locations established as <u>City of Killeen City Hall</u> and <u>City of Harker</u> Heights Recreation Center which lie within the boundaries of the district as listed below.

- 5. That all resident qualified electors of said District shall be entitled to vote at said election.
- 6. That the first day for requests for applications for an early voting ballot by mail to be received shall be January 1, 2024. The last day for requests for an application for a ballot by mail (ABBM) or federal post card (FPCA) to be received shall be April 23, 2024. Requests for ballot by mail applications may be made in person at the Killeen ISD Central Administration Building, 200 North WS Young, Killeen Texas 76543 or mailed to the Early Voting Clerk, Superintendent's Office, Killeen Independent School District, P.O. Box 967, Killeen, TX 76540.
- 7. That a substantial copy of this Order shall serve as proper *Notice* of said election, and the presiding officer of the Board of Trustees shall cause said Notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date for the election, in a newspaper published in said District. In addition, not later than the 21st day prior to the date set for the election, the presiding officer of the Board of Trustees shall cause said Notice to be posted on the bulletin board used for posting notices of meetings of the Board of Trustees.
