KILLEEN INDEPENDENT SCHOOL DISTRICT ORDER OF ELECTION

(IAW Texas Election Code Section 3.006)

THE STATE OF TEXAS: COUNTIES OF BELL AND CORYELL:

WHEREAS, this Board of Trustees deems it advisable to call the election hereinafter ordered for the purpose of electing a representative to the following positions:

School Board Trustee Place 6 (Three Year Term) School Board Trustee Place 7 (Three Year Term)

WHEREAS, it is hereby officially found and determined that holding hereafter called election on a uniform election date established by Section 41.001(a), Texas Election Code, is in the public interest; and that this was determined in a meeting open to the public for which public notice with time, place, and purpose of said meeting was given, all as required by the Texas Government Code 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE KILLEEN INDEPENDENT SCHOOL DISTRICT:

1. That an election shall be held between the hours of 7:00 A.M. and 7:00 P.M. on May 1, 2021 in said District at the regular election precincts of said District, at regular polling places as follows:

Precincts #101 and #111, Nolanville Community Center, 408 North 10th Street, Nolanville, Texas including all or part of Bell County Precincts Nos. 101 and 111, which lie within the boundaries of the District.

Precinct #106, Fire Station #1, 3800 Westcliff Road, Killeen, Texas including all or part of Bell County Precinct No. 106, which lies within the boundaries of the District.

Precinct #109, St. Joseph Catholic Church, 2903 East Rancier, Killeen, Texas including all or part of Bell County Precinct No. 109, which lies within the boundaries of the District.

Precincts #201 and #204, Fire Station #3, 700 Twin Creek Drive, Killeen, Texas including all or part of Bell County Precinct Nos. 201 and 204, which lie within the boundaries of the District.

Precinct #205, Jackson Professional Learning Center, 902 Rev. R.A. Abercrombie Drive, Killeen, Texas including all or part of Bell County Precinct No. 205, which lies within the boundaries of the District.

Precincts #206, #402, and #409, Killeen Senior Center at Lion's Club Park, 1700 E. Stan Schlueter Loop, Killeen, Texas including all or part of Bell County Precinct Nos. 206, 402, 409, which lie within the boundaries of the District.

Precinct #207, Copper Mountain Branch Library, 3000 South W.S. Young Drive, Killeen, Texas including all or part of Bell County Precinct No. 207, which lies within the boundaries of the District.

Precincts #203, #208, and #210, Cedar Valley Elementary School, 4801 Chantz Drive, Killeen, Texas including all or part of Bell County Precinct Nos. 203, 208, and 210, which lie within the boundaries of the District.

Precincts #201, #202, #111 and #209, Harker Heights Recreation Center, 307 Miller's Crossing, Harker Heights, Texas including all or part of Bell County Precinct Nos. 201, 202, 111, and 209, which lie within the boundaries of the District.

Precinct #401, #412 and #413, Fire Station #9, 5400 Bunny Trail, Killeen, Texas, including all or part of Bell County Precinct Nos. 401, 412 and 413, which lie within the boundaries of the District.

Precincts #404, #110 and Coryell Precincts #206 and #311, Killeen Fire Station #7, 3701 Watercrest Road, Killeen, Texas including all or part of Bell County Precinct Nos. 404, 110 and Coryell County Precincts, 206 and 311, which lie within the boundaries of the District

Precinct #405, Robert M. Shoemaker High School, 3302 South Clear Creek Road, Killeen, Texas including all or part of Bell County Precinct No. 405, which lie within the boundaries of the District.

Precinct #406, Central Fire Station, 201 N. 28th Street, Killeen, Texas including all or part of Bell County Precinct No. 406, which lies within the boundaries of the District.

Precinct #408, Killeen Fire Station #5, 905 Jasper Drive, Killeen, Texas including all or part of Bell County Precinct No. 408, which lies within the boundaries of the District.

Precinct #410, Fire Department Support Facility, 114 West Avenue D., Killeen, Texas including all or part of Bell County Precinct No. 410, which lies within the boundaries of the District.

- 2. That the Presiding Judge shall appoint not less than two or more than four qualified election clerks to serve and assist in conducting said election; provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks.
- 3. That early voting shall be conducted by personal appearance and by mail at the Main Early Voting Place located at the Killeen ISD Central Administration Building, 200 North W.S. Young, Killeen Texas 76543, during the period early voting is required and permitted by law, being April 19, 2021 through April 27, 2021, and during the hours designated for early voting by personal appearance being 8:00 A.M. to 5:00 P.M. on each day except Saturdays, Sundays, and legal state holidays; and the Early Voting Clerk shall keep said Main Early Voting Place open during such hours for early voting by personal appearance.
- 4. That early voting by personal appearance shall also be conducted at Permanent Branch Early Voting locations established with the respective City Halls which lie within the boundaries of the District as listed below for residents of those cities.

Killeen:

Killeen City Hall, 101 N. College Street

Killeen Community Center, 2201 E. Veterans Memorial Blvd. Killeen Senior Center, 1700 B. East Stan Schlueter Loop

Harker Heights:

305 Millers Crossing (Harker Heights City Hall)

Nolanville:

Killeen ISD Central Administration Offices

200 North W.S. Young Drive, Killeen

(Note: All other registered voters living outside the city limits early vote at the Main Early Voting site located at the Killeen ISD Central Administration Building, 200 North W.S. Young, Killeen, Texas 76543)

- 5. That all resident qualified electors of said District shall be entitled to vote at said election.
- 6. That the first day for requests for applications for an early voting ballot by mail to be received shall be January 1, 2021. The last day for requests for an application for an early voting ballot by mail to be received shall be April 20, 2021. Requests for ballot applications to be voted by mail may be made in person at the Superintendent's Suite of Killeen Independent School District at Central Administration Building, 200 North W.S. Young, Killeen Texas 76543 or mailed to the Early Voting Clerk, Killeen Independent School District P.O. Box 967, Killeen, TX 76540.
- 7. That a substantial copy of this Order shall serve as proper *Notice* of said election, and the President of the Board of Trustees shall cause said Notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date for the election, in a newspaper published in said District. In addition, not later than the 21st day prior to the date set for the election, the President of the Board of Trustees shall cause said Notice to be posted on the bulletin board used for posting notices of meetings of the Board of Trustees.
